The Stewards, having received a report from the Clerk of the Course with documentary evidence attached, summoned the above crew members, have considered the following matter and determine the following:

**Facts** Failure by the crew to activate the OK button on the emergency console within one minute after stopping on Special Stage 3 on 17/08/2018, 12:40 hrs.

**Offence** Breach of Art 40.2.4 DMSB RyR

**Decision** The crew members will be jointly and severally liable to pay a fine of € 100.

**Reason** The crew was informed accordingly by the Stewards via the CRO and was given the possibility to bring forward any representations other than having forgotten to push the button within one minute in the heat of the moment. The crew confirmed that they want to make representations and were heard by the Stewards on Friday at 22:00 hrs. In their statement they explained that they had a tyre failure and wanted to change the tyre on the stage. They admitted to activate the OK button "too late" at their stopping. They apologized for that lapse and promised to be better aware for the future.

The Stewards nevertheless consider that an infringement of Art. 40.2.4 DMSB RyR has been committed, also considering that it took 3:16 minutes in total until the crew activated the OK button and therefore the rally control had to check whether there is a case of emergency which needs further activities.

The crew is reminded of their right to appeal according to the statement of right of appeal which is part of this decision (see attachment)
